It is the responsibility of the OOS to contact the Jamboree Food Staff by email (using the address cj13Food@shaw.ca) to inform the event staff of any allergies or other health issues that would restrict the OOS from consuming food from the standard menu, and that it is the responsibility of the OOS to arrange with the Jamboree Rations Staff, by **June 1, 2013**, for the provision of modified menu items, where possible.
